TERMS AND CONDITIONS

1. PROMOTER

This competition is conducted by Cedar Woods Properties Limited ACN 009 259 081 of Ground Floor, 50 Colin Street, West Perth, Western Australia (**Cedar Woods**).

2. ENTRANT

- (a) Participation is open to any Australian citizen or permanent resident of Australia, over the age of 18, who is not a director or employee (or the immediate family member of a director or employee) of Cedar Woods or any of its related bodies corporate (**Entrant**).
- (b) Cedar Woods reserves the right to confirm and verify that Entrants are over the age of 18 by requesting proof in writing. Entries of work authored by individuals who are deceased at the time of judging will be excluded from the competition.

3. COMPETITION ENTRY

- (a) The competition commences at 9am AWST on 1 January 2018 and concludes at 5pm AWST on 11 February 2018.
- (b) Entry into the competition is free.
- (c) To enter, participants must take a picture as described on the competition website www.millarslanding.com.au/MillarsMoment and must either:
 - (i) post the picture to their own Facebook page and / or Instagram page with the hash-tag "#MillarsMoment"; or
 - (ii) upload the picture to the competition website.
- (d) The entries will be collected via ShortStack and will be judged by Cedar Woods.
- (e) The entry must fulfil all competition requirements contained in these terms and conditions, the website and the entry form, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Cedar Woods.
- (f) The Entrant may enter multiple times. The entrant must provide the information requested. If the Entrant uses fraudulent methods or otherwise attempts to circumvent the rules, the Entrant's submission may be removed from eligibility at the sole discretion of Cedar Woods.
- (g) All details provided by the Entrant must be true and accurate.

4. ENTRY REQUIREMENTS

- (a) Each entry must be an original photograph produced entirely by the Entrant. It must not contain any trademarks or copyright material owed wholly or in part by a third party or violate any person's rights of privacy.

- (b) Where there is an identifiable person in an entry, the Entrant is responsible for obtaining a signed Model Release to provide to Cedar Woods upon request (a Model Release means a release signed by or on behalf of any person identifiable in a photograph).
- (c) The entry must not contain any identifiable information of the Entrant. Entries submitted with watermarks or branding on them will not be considered for judging. Entries containing names, trademarks, signage or other identifying marks of a property developer that is not Cedar Woods will not be considered for judging.
- (d) The entry must not contain any material or content that is infringing, threatening, false, misleading, abusive, harassing, defamatory, vulgar, obscene, scandalous, inflammatory, pornographic, profane or otherwise objectionable.
- (e) The entry must not plagiarise the work of any other person.
- (f) The entry must not contain any material that could constitute or encourage conduct which would be considered a criminal offence, give rise to civil liability or otherwise violate any law either of Western Australia or Australia.
- (g) The Entrant must not upload or send any content which might disturb or damage Cedar Woods's website or reputation.
- (h) Entries that are found to have been derived from the designs or work of a third party, or otherwise breach these Terms and Conditions, will be considered invalid and, if awarded a prize, that prize must be returned to Cedar Woods.

Without limiting the generality of the foregoing, Cedar Woods reserves the right to take legal action against anyone found to have breached clause 4 of these terms and conditions.

5. JUDGMENT PROCESS

- (a) The entries will be judged by Cedar Woods administration team who will determine the weekly and grand prize winners.
- (b) The judging process will not be based on chance. There will be no correspondence between Entrants and judges throughout this process. The judges' decision in relation to any aspect of the competition is final and binding on each person who enters
- (c) Cedar Woods does not accept responsibility for late, lost or misdirected entries.

6. PRIZES
